#### Financial Report

AP Warrants 13033 – 13052 totaling \$13,770.15 were approved. AP EFT/ACH totaling \$42,478.24 was approved. Payroll Warrants 808055– 808062 totaling \$21,281.37 were approved. PR DD/EFT/ACH totaling \$116,826.15 were approved. June 2019 bank reconciliation was reviewed. AP Warrants 13032 was voided.

#### Chief's Report

- No additional information regarding the state parks contract.
- SCFD10 has had a few more couple suspicious fire starts recently in the area of Government Way/Trails Rd. DNR and District 10 have a heightened awareness.
- SHIP Grant nothing new to report.
- Fire Dispatching update:
  - CCC policy board is working with legal counsel for how to best dissolve CCC and disburse the reserve fund acquired over the last 20 plus years. More to come after resolutions are completed by each agency
  - SRECS is supporting City Dispatchers until more are hired by Spokane to meet city's needs

- Engine 10-4 is out of service with a recall, this could be about 4 weeks or more. This
  is the same frame issue that E10-1 had completed last month. All Engine chasses
  will be inspected. Freightliner has had some issues with Spartan with this recall
  effort.
- Hose testing is coming up this month. This year the District is contracting this
  project out however there will still be some of our own man hours into the project
  moving equipment around, but over a couple days instead of weeks.
- No state mobs or project fire so far this year that SCFD10 has been requested to fill needs.
- LT Mike Risley attended a fire code inspector class last week in Cheney. This was an IFSAC class and testing will be conducted on August 10<sup>th</sup> and September 14<sup>th</sup>.
- National Night out is tonight, there are two different block parties that we have been asked to attend tonight.
- We are working on updating the West Plains Recruit Academy Interlocal Agreement. We are adding SCFD 3 to the group of West Plains agencies cooperating together formally in this effort
- Fall Recruit School applicant process will close August 16<sup>th</sup>, testing the 24<sup>th</sup>. Interviews the 28<sup>th</sup>. Offers to selected potential members who will start WPRSA 2019-2 on September 11<sup>th</sup>.
- Station 2 is having an open house on 8/17 from 9am to 12noon.
- FF Bitz is in the 4th phase of probation.
- Station 4 now has the ability to wash PPE the washer was purchased with the remainder of the grant funds.
- 3 EMT graduates from INHS.
- New CO monitors for EMS bags that will be on a 2-year replacement plan
- Knox boxes are being installed this last week.
- Firefighter Zeutschel expected to return to full duty by mid to late August.

  made a motion to approve the resolution as presented; seconded by
  Commissioner McKelvey. Motion carried.
- 3. Resolution 19-06 Warrant Register Signature— AD Callahan presented Resolution 19-06 which authorizes who can sign warrant registers. Chief Johnson was appointed to replace Chief Scharff. Commissioner Mericle remained as a signer. Commissioner Mericle made a motion to approve the resolution as presented; seconded by Commissioner McKelvey. Motion carried.
- 4. Resolution 19-07 Terminate CCC Interlocal Agreement Chief Scharff presented Resolution 19-07 which will terminated SCFD 10's interlocal agreement the Combined Communication Center (CCC). Discussion followed. Commissioner Mericle made a motion to approve the resolution as presented; seconded by Commissioner McKelvey. Motion carried.
- 5. Station 10-2 and Station 10-2 Weight Room Upgrades DC Krill presented a list of proposed upgrades to the weight rooms at Stations 10-1 and 10-2. Discussion followed.
