Approval of the Agenda

Minutes from the September 25 and October 1, 2019 meetings were approved as mailed.

Financial Report

AP Warrants 13087 – 13099 totaling \$12,411.86 were approved. AP EFT/ACH totaling \$46,367.57 was approved. Payroll Warrants 808077 - 808084 totaling \$18,674.10 were approved. PR DD/EFT/ACH totaling \$104,426.84 were approved. September 2019 bank reconciliation was reviewed. Third quarter 2019 financials were reviewed.

<u>Executive Session</u> – Per RCW 42.30.110(1)(i) Commissioner Mericle took the board into executive session at 5:15pm for fifteen (15) minutes. Attendees included Chief Johnson, AD Callahan, DC Sandoval, Commissioner Mericle, Commissioner Pegg; Commissioner McKelvey and Attorney Michelle Fossum.

5:30pm – executive session was extended twenty (20) minutes.

5:50pm – regular meeting was resumed.

Chief's Report

- 2019-2 Recruit Academy is underway with 41 recruits. We are half way through the program, still experiencing logistical issues due to large number of recruits.
- Chief Johnson and FAFB Fire Chief to review position station sites near the Air Force's JPRA.

They are exploring the possibility of housing a crew at Station 10-5 while their station is being built.

- District was contacted about sending crews to California to fight wildfires. We need to have a contract with Department of Emergency Management in order to send crews.
- Chief Johnson is working with Department of Emergency Management on the District's Hazard Mitigation program.
- Chief Johnson will be attending a November 14th Spokane County meeting regarding the comprehensive plan for the county. They plan on updating the Urban Growth Area (UGA) to include Pillar Rock and to remove a residential area around Grove Road.
- We will be changing our internet provider at Station 10-2 from Hughesnet to Ptera.
- Chief Johnson is interested in applying to the Executive Development Institute Program for new fire chiefs. He requested a letter from the board okay his application. Letter signed by Commissioner Mericle.
- A local fire district had three of the stations not counted by WSRB because they didn't have sufficient staffing at or near the stations.
- District will be doing Ladder inspections and repairs in November.
- District just completed Pump testing and air sampling testing.
- Spokane County has asked to park a grader at Station 10-5 for the winter.

Old Business

1. Review and discuss follow up from roundtable discussion – Lt Risley briefed the board on the Prevention department activities.

New Business

Chief Johnson briefed the board on the I Roll Program for Prevention activities.
 Commissioner McKelvey made a motion to approve Chief Johnson signed a contract with I Roll; seconded by Commissioner Pegg. Motion carried.
