Summer is almost here and I hope everyone's had the chance to regroup from last year's record-setting fires and natural

disasters. We should all be preparing now for the season ahead.

This year's weather has similarities to last year in our area. Snow pack levels are higher (closer to normal), but it's melted



off very early and weather patterns are 3-5 degrees warmer than normal, which potentially sets the stage for another unprecedented fire season .

I encourage everyone to plan ahead and take action around your house and property by clearing out and removing all dead fuels (i.e. dead trees, branches, twigs and weeds) and keeping grass mowed in order to provide a fire-preventive environment. Keep power lines and rights-of-way clear of dead/dying trees. This may require contacting a trained specialist to complete the job. This also provides a safer environment for firefighters who are battling the flames. These minor efforts make major differences when it comes to saving or losing your home if a wild fire flares up.



- Grasscycling is a simple, natural approach to lawn care. Any lawn mower can recycle grass clippings. Just remove the grass bag/catcher. Mowers specifically designed for mulching are available and they produce finer clippings for grasscycling.
- Grass clippings are a natural organic fertilizer. Your lawn retains its health because each time you mow, you return valuable nutrients and moisture to the soil.
- Grasscycling does not cause thatch—it is caused by improper watering. Here are some more tips for grasscycling:
- Mow when the grass is dry. Never cut off more than 1/3 of the grass blade in one mowing. Keep grass mowed to 2" in early spring. Gradually raise
- P Home composting is an economical and convenient alternative to bagging yard debris that is usually picked up or hauled by you to transfer stations. Composting takes ordinary yard and kitchen waste and transforms it into a superior soil amendment. Your plants will be healthier and more able to deal with insects and disease. Compost also aids in water absorption and minimizes the need for chemical fertilizers.

Steps to building a compost pile:

Choose a site close to a water source if possible and preferably in the shade. Start your compost pile on bare earth to allow worms and other beneficial organisms to enter your pile and begin the decomposition process.

- Some residents choose to chip their branches and other wood debris. Chippers may be rented or a chipping service hired to take care of your material.
- Wood chips make excellent mulch around trees and shrubs and can also be used to soften garden paths.
- Mulching keeps the soil loose and moist, smothers weeds, prevents soil loss, and releases nutrients as it decomposes.
- By mulching, we can easily put nature's recycling system to work in our own backyard. Spread yard and garden debris around shrubs, trees, and other plantings.
- Mulch in your own backyard with natural materials: dried grass, chipped woody material,


















During a wildland fire, local animal rescue organizations work with law enforcement and fire departments to rescue as many animals as they can. In battling a wildfire, firefighters will do what they can but they are not responsible for evacuating your livestock. Firefighters may cut fences or open gates to free trapped animals.

Livestock Disaster Preparedness Kit

- Hay, feed and water for three days
- Non-nylon leads and halters
- First aid items
- Wire cutters and a sharp knife
- Hoof pick
- Leg wraps
- Shovel
- Water buckets
- Plastic trash barrel with a lid
- Portable radio and extra batteries
- Flashlights

Pet Disaster Preparedness Kit

- Pet carrier for each pet
- Two week supply of food and water
- Non-spill food and water bowls
- Pet first-aid kit
- Medications and dosing instructions
- Cat litter box and litter
- Plastic bags for waste disposal
- Paper towels
- Disinfectants
- Leashes/collars/harnesses
- Blankets

If You Must Leave Your Pet

- If you must leave your pets, bring them indoors. Never leave pets chained outdoors!
- Use a room with no windows and adequate ventilation, such as a utility room, garage, bathroom, or other area that can be easily cleaned. Do not tie pets up!
- Leave only dry foods and an extra large bowl of fresh water in non-spillable container.

SPOTLIGHT: Deputy Chief Mitch Metzger

Starting in the fire service May 11, 1981, Metzger came to the Spokane area in 2004 and volunteered with Fire District 8. In 2008 he was hired as a division chief. He previously served with Bellevue, Spanaway, Enumclaw and Worley, Idaho fire departments. Metzger was selected as Airway Heights' fire chief, following the retirement of the prior chief in June 2011.

Growing up on a farm in Ferndale, Wash., Metzger learned his job responsibilities at an early age. "Part of farming is helping your

neighbors," he said. "It didn't matter what they were doing, if they needed help with something, you went over to help and vice-versa."

Metzger and his wife Kelly of 31 years raised two adult children who attended college in Eastern Washington.

Metzger also instructed at Spokane Falls Community College. Last year marked his sixth year as a board member with the American Red Cross. "The Red Cross works so much with the fire service that it's pretty natural to me," he said. Through a contract for services, Metzger has been appointed as Deputy Chief of Operations at SCFD10, effective April 15, 2016.
