Chief Scharff reported the department is still working on an agreement with BLM for fire mobilization reimbursement. He reports that there are several other departments working with BLM to craft an agreement. He hopes to have more at the next meeting.

New radios from the county will be arriving soon. These are paid by the county. It will require that we upgrade our pagers. The upgrade cost will be covered by the county.

- 3. Vehicle Purchase (two) Chief Scharff presented pricing information for the purchase of two new vehicles; one for the new deputy chief and one to replace vehicle #129. Chief Scharff contacted the state purchasing department to get bid prices. The state has stopped taking orders for 2013 vehicles and will begin taking order for 2014 vehicles in June, with a late fall delivery date. Chief Scharff contact three vendors on our vendor list asking for quotes. He received quotes from Appleway Chevrolet, Dave Smith Motors and Camp Chevrolet. Appleway Chevrolet was the low bid. Discussion followed.

Motion made by Commissioner Pegg to purchase, using the vendor list, a 2013 1T 4X4 vehicle from Appleway Chevrolet for \$36,453.02 plus tax, plus modifications, if necessary. Seconded by Commissioner McCoury. So moved.
