Present

Commissioners Jim McKelvey, Jerry McCoury and Ken Pegg; Administrative Director Pegy Callahan; Deputy Chiefs Robert Ladd and Orlando Sandoval. Chief Scharff had an excused absence.

Approval of the Minutes

Minutes of the January 7^d and January 28 meetings were approved as mailed.

Financial Report:

AP Warrants 9630 – 9713 totaling \$44,968.17 were approved, Payroll Warrants 807166–807208 totaling \$28,102.70 were approved. AP EFT/ACH totaling \$30175 and PR DD/EFT/ACH totaling \$70,317.60 were approved.

<u>Pinning Ceremony</u> – Lt. Ed Bolyard was sworn in at the pinning ceremony. Ed will serve as Station Lieutenant at Station 10-5.

Meeting was adjourned at 6:10pm for Pinning Ceremony reception.

Regular meeting resumed at 6:17pm.

Chief's Report

- H1N1 Flu bug has seen increase in January in Spokane County (36 Nature code)
 Safety alert and Guidelines
- 2013 Year in Review Handout
- PL 10-1 Modifications have been completed
- Admin SOP updates/revisions. SOG continual in process.

- Received Order of new pagers (155) through County SRECS. Will hand out as needed until switchover to new pager programing is implemented later
- New radio system. Law Enforcement side could possibly go live soon this month.
 Fire still hopeful to go live in late in spring but has given the county a May 15 cutoff date. After that day they will have to wait until summer fire season is over.
- Pulse Point program. Feb 14th kick off for CPR type medical calls. Not much change for District 10 area as commercial building only applies by address for dispatches.
- WSRB Discussions have provided for WSRB to allow 5-7 mile from fire station rate of class 9 from 9A previously. Still more discussions on topic will occur after statistics are gathered. District 10 has about 31 Parcels in the 5-7 mile range with unknown if structures are present on parcel. Many other Districts have a much bigger impact such as SCFD 4 (735)
- BC Program update three candidates went through the process and conditional job offers have been made to two of the candidates. DC Ladd hopes to have them in place within the next month.

Old Business

- Final Budget AD Callahan presented a final budget for approval. Discussion followed regarding being able to utilize seasonal fire fighters at all stations. Commissioner Pegg made a motion to approve the budget as presented; seconded by Commissioner McCoury. So moved.
- 2. Cooperative Service Agreement DC Ladd reported that the City of Medical Lake and the City of Airway Heights have both signed the Memorandum of Agreement.

New Business

- ESCI Contract AD Callahan presented the ESCI Contract for approval. This
 contract was discussed at a January 29, 2014 special meeting with Consultant
 Lane Wintermute. Commissioner Pegg made a motion to approve the contract as
 presented, seconded by Commissioner McCoury. Commissioner McCoury
 commented that thinks that Fire District 3 should be involved in the feasibility
 study and Commissioner McKelvey mentioned his concern about SCFD10 being
 on the sole agency signing the contract with ESCI. Discussion followed. Motion
 carried.
- 2. DC Sandoval Salary Review Commissioner McKelvey tabled this item until input from Chief Scharff has been received.

3. Surplus Items – AD Callahan presented a list of items to be surplused. The majority of the items are microwave electric equipment that was purchased by the district several years ago when the county was considering building microwave towers for internet access. The county decided not to build the towers and the equipment could not be returned to the vendor. Commissioner Pegg made a motion to approve the surplus items list; seconded by Commissioner McCoury. So moved.

Commissioner McKelvey took board into Executive Session at 7:12pm for 30 minutes per RCW 42-30-110 (g).
