Approval of the Agenda

Approval of the Minutes

Both sets of minutes from October 24, 2016 meeting were approved as mailed.

Financial Report

AP Warrants 12226 – 12294 totaling \$46,282.88 were approved. AP EFT/ACH totaling \$38,842.63 was approved. Payroll Warrants 807864 – 807872 totaling \$11,600.36 were approved. PR DD/EFT/ACH totaling \$80,266.90 were approved.

Chief's Report

- SRECS 800 MHz Communication recent failure issues in September. There an
 unsubstantiated rumor that failure was an "electronic storm" caused by a traffic
 camera using network of 800 system. We are told system filters have been put in
 place to avoid that same occurrence from happening again.
- City of Spokane recently approved inter-local agreement for SCFD10 Opticom use.
- The CCC dispatch agreement is still being worked on. Should have an update next month.
- Chief Scharff attended Snure seminar 10/26 and WFCA conference Oct 26-29 in Yakima WA. No noteworthy changes.
- Paving gravel parking area and overlay old asphalt ramp was completed last week at Station 10-2.

- Installing back up Gen Set at 10-2. Natural gas powered unit just little over \$10K cost with auto switchover controls. Hopeful to have complete by year end. Will be looking to complete two more stations with LPG units 2017 budget year.
- District looking at employee health care coverage from WFCA. Appears District will save some dollars and still maintain very good coverage. Local 2916 MOU being worked on.
- Per Endirus, Blackburn case should be concluding this month.
- Pegy attended at recent Vision Conference (our financial and payroll software). We are looking to upgrade payroll and add a purchase order system.

Training Update -

- Recruit academy is going well, we used SCFD3 training prop last weekend.
- Maintenance is building anhydrous ammonia tank training prop. With a tank that was donated by local vendor. Will be used for Hazmat spills training.
- Working with FAFB secure to use of base facilities as a IFSAC FF test site for future testing location.

Maintenance Update -

- Considering lighting incentive programs for LED Lighting upgrades at all facilities (Avista, Inland Power and Bonneville Power all have programs).
- Annual Engine Pump testing coming due next month, looking at another 3rd party vendor from past. Maybe more cost effective and convenient.
- Recently had an apparatus backing incident that required some building repair at Station 10-1. Truck good shape. So far in house repair and door adjustment by Overhead Door Company.
