### Financial Report

#### Chief's Report

- Still working on generator installation at Station 10-2.
- Blackburn case has been settled.
- E10-5 was at Cummins for an EGR valve issue. It is now back in service.
- Lt Anderson has resigned from the district FF Risley will fill in on an interim basis
- We have started recruiting for 2017-1 recruit academy which will begin in early February.
- Chief Williams (City of Spokane Fire Department) is retiring.

• Our lighting replacement program is in process.

## **Old Business**

- 1. CSA Update Chief Scharff and AD Callahan met with Chief Metzger and CAWH City Manager Albert Tripp to review the services contract. We will continue to meet quarterly. City Manager Tripp suggested an informal get together for Board of Fire Commissioners from District 10 and council members from CAWH. We will work on getting this scheduled. Chief Scharff, AD Callahan and Chief Metzger met to review financials and suggested that CAWH also review financials as it pertains to the possibility of an annexation.

- 3. CCC Agreement Chief Scharff presented a revised CCC Agreement that lists all participating agencies as members and SVFD as a user, as SVFD requested a month-to-month agreement. Commissioner Pegg made a motion to approve the agreement; seconded by Commissioner Mericle. Motion carried.

- 3. New Chairperson Election Commissioner Pegg made a motion that Commissioner McKelvey will continue to serve as Chairperson and that the election be held in six months. Seconded by Commissioner Mericle. Motion carried.
- 4. New Copier Lease Agreement AD Callahan reported that current copy machine is being phased out (parts no longer available). A replacement machine has been located. Commissioner Mericle made a motion to allow AD Callahan to sign the lease agreement with Copiers NW. Seconded by Commissioner Pegg. Motion carried.

<u>Public Comment – Commissioner McKelvey opened the meeting up to public comment.</u> Commissioner McKelvey made a motion to have Commissioner Pegg serve on Board of Volunteer Fire Fighters Board. Seconded by Commissioner Mericle. Motion carried.
