Financial Report

AP Warrants 13348 – 13361 totaling \$40,110.14 were approved. AP EFT/ACH totaling \$63,619.86 was approved. Payroll Warrants 808200 - 808200 totaling \$879.63 were approved. PR DD/EFT/ACH totaling \$138,547.10 were approved.

Chief's Report

- 1. We have had three shot clinics at our station where we have offered on average of 300 shots.
- 2. Training prop building permit approved, and we now see some activity on site.
- 3. Postal service requesting to put a 16 unit box at station 5 to protect their driver who delivers mail on Trails Rd.
- 4. We did put together an application for the Safer grant, but we did not submit the grant due to a technical approval that was not clear during the application process, causing us to miss the deadline. It sounds like we were not the only ones who did this; the good news is that we have an application ready for next year.
- 5. April 24th was the National Drug Take-Back program; Walmart Parking Lot collected three 2'x2' boxes full.
- 6. Recruit school is finishing up wildland and will be preparing for HazMat training and IFSAC testing this month.
- 7. Our annual state audit is in the process this week.

- 8. Several people are taking the Assessing Structure Ignition Potential from Wildfire.
- 9. The staff has been busy getting all the station's spring work done.
- 10. The Inland Empire Chiefs Association provided a letter of intent to officially start the process regarding a training center at Rambo and Hwy 2.
- 11. We are considering an upgrade to our air compressors, so we have a possible funding source (grant) to assist with the purchase.

New Business

- Avista Agreement Chief Johnson presented a Memorandum of Understanding between Avista and Spokane County Fire District 10 regarding Avista's Dry Land Conditions Program. Commissioner Hester made a motion to have the district sign the MOU; seconded by Commissioner Pegg. Motion carried.
- SRHD Agreement Chief Johnson presented a facilities use agreement between Spokane Regional Health District (SRHD) and Spokane County Fire District 10, which allows SRHD to use district facilities (parking lot at Station 10-1) to hold vaccination clinics. Commissioner Hester made a motion to have the district sign the Agreement; seconded by Commissioner Pegg. Motion carried.
- 3. SOP Update Deputy Chief Sandoval presented SOP 900.02 Burn Building. This is for use of our new burn building at Station 10-1. Commissioner Pegg made a motion to approve the SOP as presented; seconded by Commissioner Hester. Motion carried.
- 4. Resolution 21-01 Summer Crew Hours and Pay AD Callahan presented Resolution 21-01 which rescinds Resolution 20-05 and outlines dates and pay for 2021 Summer Crew. Commissioner Pegg made a motion to approve the resolution as presented; seconded by Commissioner Hester. Motion carried.
