Approval of the Agenda

Minutes from the September 6 and September 21, 2022, meetings were approved as mailed.

Financial Report

AP Warrants 13594 – 13608 totaling \$50,875.78 were approved. AP EFT/ACH totaling \$124,544.53 was approved. Payroll Warrants 808226 – 808228 totaling \$4,098.12 were approved. PR DD/EFT/ACH totaling \$198,691.32 were approved. August 2022 bank reconciliation was reviewed.

Chief's Report

- 5% ahead of last year in 911 calls. 128 incidents for September.
- WSRB scheduled for October 5- Updating the checklist
- Fire Dispatch SREC- Budget info for the year
- · Safer Grant awarded.
- Indian Village Estates Water Association hydrant training, working on use agreement.
- DNR agreement has not been finalized yet.
- Command Unit replacements adding 2 Tahoe's- Because they are fleet purchases, they are \$25 thousand cheaper per vehicle then the current market price. We were planning the second Tahoe for 2023, purchasing the 2nd vehicle this year saved \$10,000. Pickups to be used as support vehicles.

- DNR has 18 type 6 and type 3 engines, we will submit for one.
- Chiefs and DNR are discussing reducing burn restrictions soon.
- We provided another letter of support to the West Plains Connection
- Turning away residents because we don't have any more rooms.
- We are beginning recruiting for lateral firefighters.
- Budget Meeting on October 26th.
- Spokane County Building & Planning is seeking non-voting members for the Spokane
 County Steering Committee of Elected Officials (SCEO). The SCEO oversees Countywide
 Planning Policies, reviews growth projections, recommends urban growth area
 boundaries, and other functions. We are formally circulating a non-voting member
 application to represent the fire districts.
