Chief's Report

- We switched over to ESO today.
- Contract negations are nearing completion
- Lots of projects have been getting completed. (Sign replaced, hose rack for Sta 3 built, Security Systems at stations coming online, Mattress replaced at Sta 2 and many other positive repairs and updates.
- Several new pre-con meetings- commercial businesses. County says the projects are not slowing down but increasing.

- A10-1 has been putting a lot of hours on it during the wildland season.
- SCFD#4 now has its own ALS ambulance transport license.
- The ambulance service board requested a small group to begin collecting information for an improved Ambulance Service Agreement. Negotiations will start next year.
 Spokane Valley Fire may not be a part of our County Agreement next year; they may opt for their own agreement.
- Spokane County Public Works Meeting- Jacobs Rd Concerns long range plans/ Shared Water Supply for future needs/Trails road traffic solution Risk Mitigation.

Old Business

- Roundtable Meeting Follow Up Lt Sayers reported on activities of the maintenance department – items included apparatus updates; dot inspections; ladder inspections; hose testing
