Chief's Report – given by Assistant Chief Malone

- District has three grants pending totally about \$2.7M (Dept of Ecology, Community Wildfire Foundation, Spokane Tribe)
- Two new career firefighters will be starting 1/3/2024
- District will be holding Lieutenant testing for Career, Volunteer and Support Services in addition to firefighter testing to create an eligibility list.
- Career members now have a Step process for advancement went into effect with their new CBA
- Administrative staff working on updating job descriptions and SOPs
- Architect working on station 5 remodel addressing issues with septic
- Water filtration system was installed at Station 10-3. Test results came back with decreased levels of PFOA and PFOS. We will plan in installing same system at 10-4 and 10-5

• West Plains Recruit Academy held an instructor recognition ceremony in December. Coins were given to folks. DC Steevens recognized FF Jimno for her assistance with getting the recruits outfitted with uniforms and turnouts. Coins were also handed out to Commissioners as a thanks for their support of the training department.

The individual who had the most votes in the 2023 general election has declined to be sworn in. Commission will follow up with Elections Office and this will be tabled until next meeting.
