
Taylor resides in the West Plains with his wife and daughter. In his free time, he enjoys fishing, boating, shooting, and spending quality time with his family.

### Fire Fleet

Members of the maintenance team recently traveled to the Rosenbauer plant in Sioux Falls, South Dakota, to complete the final inspection of our newest apparatus, a Freightliner Timberwolf. The inspection process included a pump test, a test drive, and verification of all custom features ordered.

The Timberwolf is a fire truck built on a Freightliner cab and chassis, with a custom box manufactured by Rosenbauer. It is designed for both urban and wildland firefighting. Equipped with a 750-gallon water tank, the Timberwolf will also carry a variety of firefighting equipment, including extrication tools.

This new apparatus will be stationed at 10-2, serving the east side of District 10 during its first year in service.

For the past 16 years, he has been a senior field service technician at Western States Cat, further expanding his experience in technical operations and team collaboration. As a board member for District 10, Evan is committed to strengthening our department through proactive decisionmaking, collaboration, and transparency. By fostering a culture of continuous improvement and accountability, he aims to enhance our capabilities in all areas—ensuring that we become an even stronger and more resilient department.

### Training Highlights

#### **Rescue Taskforce (RTF)**

We are in the process of launching our Rescue Taskforce (RTF) program. Training has begun for all district members and will be completed by early April 2025. At that time the program will go live and we will be carrying ballistic vests and helmets on our first out engines and all crews will be trained to respond to active shooter incidents in conjunction with law enforcement agencies and neighboring fire departments-districts.

#### Water Rescue Awareness

We would like to thank the Spokane Fire Department for instructing Fire District 10 members on water rescue awareness training in February. We recently purchased life jackets (PFD's) and rope throw bags for the first out engines to assist the water rescue team from the Spokane Fire Department in the event of a water rescue on the Spokane River. We are planning to train with them throughout the year.

#### **Training Facility Updates**

We are excited that we will be updating our training tower at Station 10-1 in Airway Heights. We will be adding 3 containers and interior stairs to our prop which will give us more ability for more advanced training scenarios. We are also looking to add a standpipe system in the future. We have also purchased a stainless steel propane car fire prop which will arrive at the end of June. This prop will prepare us better for fighting car fires.

### **EMS Education**

Spokane County Fire District 10 is proud to partner with EMSConnect LLC to provide an in-depth Emergency Medical Technician (EMT) course for its members. Over the course of 14 weeks, eight dedicated SCFD10 members are undergoing extensive training to develop the skills necessary to provide high-quality prehospital care.

Throughout the program, students learn to assess and treat a wide range of medical conditions and life-threatening emergencies, preparing them to respond effectively in critical situations. Upon successful completion of the course, participants will take the National Registry of Emergency Medical Technicians (NREMT) exam, a required national certification to become an EMT in Washington State.

This training reflects SCFD10's ongoing commitment to strengthening emergency response capabilities in the community. ### Fire Chief's Corner

As we move into the second quarter of 2025, I want to take a moment to reflect on the incredible work accomplished by the dedicated men and women of Spokane County Fire District 10. The first three months of the year have been a testament to the professionalism, resilience, and commitment of our firefighters, volunteers, and support staff. From responding to emergencies to strengthening community ties, this district continues to set a high standard for fire service in our region.

#### **First Quarter Successes**

- Emergency Response Excellence: With the close of 2024, our call volume has increased over 46% in the last four years and is expected to continue that trend, with calls ranging from structure fires, hazardous materials incidents, vehicle accidents, and medical emergencies. This increase underscores our community's growing needs. The efficiency and skill demonstrated by our crews have led to improved response times and better outcomes for those we serve.
- **Training & Readiness:** Our team has already completed significant training, including Swiftwater Awareness Rescue Training, Emergency Bail-out Training for self-rescue in the event of a flashover or significant fire growth during firefighting operations, Fire Officer I Leadership training, and other advanced firefighting tactics, medical response, and specialized rescue operations. This dedication to continuous training ensures our readiness for any challenge.
- **Community Engagement:** We've continued to strengthen our presence in the community through station tours, fire safety messaging, and smoke alarm installs. Public education remains a key pillar of our mission to prevent emergencies before they happen.
- Station 10-2 Relocation Progress: Work continues on options to relocate Station 10-2 to the Thorpe and Grove area, a move that will enhance our ability to serve the community more effectively. We are making great strides in securing resources and finalizing logistics for this critical project.

In February, we gathered for our annual banquet to recognize the outstanding service and achievements of our team members. It was an evening filled with camaraderie and well-deserved recognition. 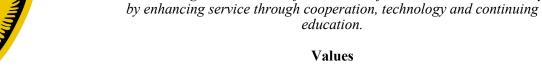
